

EVENTS.COM AI/XR SURVEY SWEEPSTAKES

OFFICIAL RULES AND TERMS/CONDITIONS

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. **Eligibility:** Events.com ("Sponsor") AI/XR Sweepstakes ("Sweepstakes") is open only to legal residents of the 50 United States and the District of Columbia who are at least 18 years of age at the time of entry, and who at the time of entry are professionally involved in organizing, planning, or managing events as part of their job or business. This includes, but is not limited to: event planners, producers, conference organizers, trade show coordinators, venue managers, or individuals responsible for event marketing or operations ("Entrant"). Sponsor reserves the right to verify eligibility based on information submitted through the survey or other reasonable means. Entrants who do not meet these criteria, or who submit incomplete or false information, will be disqualified at Sponsor's sole discretion. Void where prohibited or restricted by law. 8. **Winner Select & Notification:** Two (2) potential winners will be selected in a random drawing conducted by Sponsor or its agent from all eligible entries received. Drawing will occur within five (5) business days of Sweepstakes Period. Potential winners will be notified via submitted email and must respond within seven (7) calendar days to claim the prize. Failure to respond in time will result in prize forfeiture. Sponsor shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of incorrect or otherwise non-functioning contact information. If the selected winner(s) cannot be contacted, is ineligible, fails to claim the prize within 72 hours from the time award notification was sent, or fails to timely return any required information for prize collection, prize may be forfeited. - iii. Force majeure events

- v. Any other causes beyond the reasonable control of Sponsor that, in Sponsor's sole judgment, corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes.

11. **Tampering/Fraud:** Sponsor reserves the right to disqualify any individual found to be tampering with the entry process, or violating the Official Rules or Terms & Conditions of this Sweepstakes. Any attempt to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil laws. 14. **Dispute Resolution; Arbitration Agreement; WAIVER OF JURY TRIAL.**

a. Informal Dispute Resolution: Prior to initiating any formal dispute resolution proceeding, Entrant and Sponsor agree to attempt to resolve any dispute, claim, or controversy arising out of or relating to the Sweepstakes, these Official Rules, or the rights and obligations of the parties (collectively, "Disputes") through good-faith informal negotiations. Informal negotiations shall be initiated by written notice from one party to the other and must continue for a period of at least thirty (30) days before either party may commence arbitration or other formal proceedings.

b. Mediation: If the Dispute is not resolved through informal negotiations within thirty (30) days, either party may propose, and both parties may agree to attempt, non-binding mediation administered by a mutually agreed-upon neutral third-party mediator located in San Diego County, California.

c. Binding Arbitration: If the Dispute remains unresolved after the informal resolution period (and optional mediation, if pursued), the Dispute shall be resolved through final and binding arbitration administered by the American Arbitration Association (“AAA”) in accordance with its Consumer Arbitration Rules. The arbitration shall be conducted before a single arbitrator in San Diego County, California. Judgment on the arbitration award may be entered in any court of competent jurisdiction.

i. Waiver of Class and Representative Actions: To the fullest extent permitted by applicable law, Entrant and Sponsor agree that any arbitration shall be conducted only on an individual basis and not as a class, collective, consolidated, or representative proceeding. The arbitrator shall have no authority to consolidate claims or to hear claims on a class or representative basis.

ii. Severability: If any portion of this arbitration agreement is found to be unenforceable or invalid under applicable law, the remainder shall remain in full force and effect.
